The meeting was called to order at 1:05 p.m. by Facilitator Darla Youngs

- I. REVIEW OF MINUTES:
 - Minutes were reviewed from the November 2012, and January 2013 meetings.
 - A motion was made to approve the minutes by Carl Good, seconded by Holly Waterfield; all approved (7 ayes).
- II. TREASURER'S REPORT:
 - Scott Fickbohm was not present at the meeting; therefore no treasurer's report was available.
- III. OLD BUSINESS:
 - This meeting was supposed to be a topic meeting; however a presentation by Les Hasbargen will occur at a later date.
 - Matt Albright and Holly Waterfield will present on Walleye stocking in Otsego Lake.
 - A request for proposals (RFP) regarding projects associated with water was brought to discussion by Darla Youngs.
 - The DEC grant from Scott Fickbohm of \$4800 is available in WQCC. This will be used to fund water-related project.
 - Darla will email a draft RFP for commenting
 - Criteria is from Bylaws No. 1 and No. 2
 - A decision needs to be made for who the grants will be available to, and what date proposals will be accepted until.
 - An approval of the RFP language will take place at the March meeting.
 - Carl Good stated he would only like non-profits; Holly Waterfield asked about schools?
 - i. Jill Eichler said that schools are not 501C-3.
 - Erik Miller suggested non-profit, 501C-4, Chamber of Commerce. Allied Biological--would be excluded if not allowed.
- IV. NEW BUSINESS:
 - Vince Stayler is meeting with OCCA, SWCD, and Caitlyn Stroosnyder on funding for mailing of Goodyear Lake study.
 - Erik Miller stated that 2 Regional Development Analyst positions are available at STERPDB. Based in Binghamton, but they are regional. Available online at STERPDB website.
- V. DEPARTMENT REPORTS:
 1. Biological Field Station:
 - Aquatic Ecologist position is sought for BFS
 - Pool of candidates is down to 4
 - Fall semester—2013 is the anticipated start date.

- Tony Capraro gave a tour to SUNY Cobleskill students on watershed management.
 - Trip took students to tertiary treatment in Cooperstown—BFS is considering an educational kiosk.
 - This is a potential WQCC project idea.
 - Project wide map included—SRBC is a possibility.
2. Goodyear Lake Association
 - Caitlyn Stroosnyder is ready to mail out documents—a 6 page survey
 - GLA wants to make it more specific
 - \$2100 available for this, still \$1000 missing from a matching grant.
 3. Otsego County Conservation Association:
 - Darla reported that she worked on the RFP
 - OCCA is currently interviewing candidates for the Environmental Planner position—6 candidates.
 - Initial interviews now, with a decision coming in a few weeks.
 - Over \$80,000 was raised for 83 water tests in the County.
 - Grant proposal through the Catskills Headwaters Research Institute on costs to analyze data and write report.
 - Earth Festival is April 13—OCCA is sponsoring.
 - OCCA Lake Appreciation day is July 13—a day to appreciate the Lake with a free picnic.
 - OCCA is sponsoring interns at SWCD for surface water sampling, and summer interns at BFS.
 - Vince wanted to reach out to Sidney High School because of their water testing laboratory.
 4. Otsego County Planning Department:
 - An update on the Cleaner, Greener Communities and Hazard Mitigation Action Plan (HMAP) were given.
 - Draft HMAP is available on the Otsego County Planning Dept. website.
 5. Otsego Lake Association:
 - Nothing new to report until March meeting
 6. Otsego Land Trust:
 - Not present, but Darla heard from Marcy Foster who will be their representative at WQCC beginning next month.
 7. BOCES
 - Jill Eichler stated there are 15 students in the Initial Operator Class D program
